

# **2020 - RENEWAL PACKET INSTRUCTIONS**

All renewing members, please fill out the Renewal Form and affix your current NRA information. Even if you have no changes/have paid ahead, please fill out and send in the renewal form to ensure the AVGC has accurate and current information for the corporate files.

## **Renewal Fees**

**Senior members**, those 65 and older in 2020, dues are \$48.00 for 2020.

**Regular members**, those 64 and younger in 2020, dues are \$120 for 2020.

**New Senior/Regular members** who joined in October/November/December, 2019 have already prepaid their 2020 dues. NO renewal fees are due.

**Associate members**, NO renewal fees are due.

## **Work Fee or “Buy-Out”**

If you did not complete the six hour work requirement during 2019, please pay the \$100 “buy-out” fee in addition to your membership renewal fee. Probationary members perform four hours.

## **Work Fee Exemptions**

**Associates:** Exempt from all work requirements.

**Age:** If you turned 80 in 2019 you are exempt from fulfilling any further work requirements.

**Medical:** If you turned in a medical exemption, you are exempt from fulfilling any further work requirements.

## **Packet Instructions**

1. Please completely and **CLEARLY** fill out the renewal form. Please make sure you date, print and sign your name on the Waiver on the **reverse side** if in agreement. If you provide an email address, the quarterly newsletter will be emailed to you. Otherwise, you can pick up a copy at the clubhouse or General Monthly Meeting. If you have paid ahead, please complete the renewal form and write “paid ahead” on the fee line. Attach a copy of your NRA card or magazine label and enclose all appropriate fees with the registration form.

2. Cast your votes (Regular and Senior members) and seal the ballot sheet in the 2020 Ballot envelope. Print your name on the ballot envelope so your voting eligibility can be verified. The ballot will be removed from the ballot envelope before they are forwarded to the ballot counting committee. Associate and Probationary members do not vote.
3. Place everything in the provided return envelope. You can mail the envelope or drop it in the black box in the Clubhouse. If you choose to drop it in the Black Box please prepare it fully as if you were mailing it (sans stamp). This envelope must be postmarked or in the black box on or before February 1, 2020 for your ballot to count and your renewal counted as current.

Your renewal is considered late **after** February 1, 2020. To ensure you get the new card/gate code on time, please pay your dues ON TIME. If you pay late, your card may be late. The gate combination will change on March 1, 2020.

**Late fees** will be assessed beginning February 2, 2020 at 150% of your annual dues (Regular: \$180 and Senior: \$72). After March 2, 2020 they will be 200% of your annual dues (Regular: \$240 and Senior: \$96).
