hereby give my child express permission and consent to be lent and to possess bows and arrows, firearms (both handguns and long guns) and ammunition

for purposes of engaging in lawful, recreational sport at Apple Valley Gun Club (the "Club"). (Cal. Penal Code, §§ 27945, 29610, 29615, 29650, & 29655; 18 U.S.C. § 922(x)). As used in this form, "firearms" include any handguns, long guns, or shotguns that may lawfully loaned to and possessed by a minor under state and federal law. I also give my child express permission and consent to possess, and for a person to loan to my child, a "BB device" or air guns or air rifles as defined in Cal. Penal Code § 16250. (Cal. Penal Code, § 19915).

This consent for lending bows and arrows, firearms, ammunition, air guns or air rifles and BB devices is valid, absent my express revocation thereof, for ten (10) days from the date of my signature. A photocopy or facsimile of this written consent will serve as an original.

Further, with regard to my minor child(ren), I VOLUNTARILY AGREE TO EXEMPT and relieve the Club, and its principals, members, officers, directors, employees, agents, administrators, successors, and assigns (hereinafter collectively the "Related Parties"), from liability for personal injury, property damage, or wrongful death caused to my minor children by the act or omission of another. I also AGREE TO DEFEND, INDEMNIFY, and HOLD HARMLESS the Club and any of the Related Parties from and against all claims, losses, damages, and costs caused by, arising out of, or related to the actions or omission of any minors whom I bring or allow onto the Club property or who participate in a Club-sponsored or affiliated event, whether such event occurs on or off of Club property, and further AGREE TO DEFEND, INDEMNIFY, and HOLD HARMLESS the Club and any of the Related Parties from and against all claims, losses, damages, and costs arising out of or related to claims brought by or on behalf of any minors whom I bring or allow onto the Club property or who I allow to participate in a Club-sponsored or affiliated event, whether such event occurs on or off of Club property. But for my agreement to defend, indemnify, and hold the Club harmless from all such claims regarding or involving minors, the Club would not allow me to bring such minors onto its property or allow such minors to participate in events sponsored by or affiliated with the Club. The obligation I undertake includes the obligation to immediately defend the Club from any and all such claims and I assume all risk of the activities of any minor identified herein. This indemnity agreement, and the defense and indemnity obligations hereunder, survive the expiration of term of any other portion of this agreement as to the lending of bows and arrows, firearms, ammunition, air guns or air rifles or BB devices.
