Subject: Letter of Opposition SB 918: Firearms

Dear Senator Portantino,

On August 17, 2022, I sent a letter of opposition to SB 918 to all San Bernardino County Assembly Members to urge a "No" vote on the Assembly Floor.

This bill and your press release suggest that CCW holders are responsible for gun violence in this country. This perception of CCW holders does not reflect my experience with law-abiding citizens who possess CCWs in San Bernardino County. CCW holders in this county have used firearms for lawful self-defense and have survived threats of death or great bodily injury to themselves.

This bill appears to be an effort to remove a significant portion of the CCW process from local control and representation of citizens in this county and move this control to the state. In my opinion, the proposed process appears cumbersome and dissuades citizens from pursuing a CCW to provide for their protection and their families.

In San Bernardino County, over 11,000 CCW holders represent Democrats, Republicans, minorities, and all of those who feel that the ability to possess a firearm is a fundamental right to protection. Some media outlets and activists try to portray the CCW holders, and the program itself, as part of the gun violence epidemic in this country. This is not the truth. CCW holders are law-abiding and deserve to be portrayed as such. Criminals are committing the gun violence we see in this country. Lumping in CCW holders who are good citizens, friends, and neighbors is wrong.

For the above reasons, I am in opposition to SB 918. Please contact my Legislative Liaison Sergeant Julius McChristian (<u>imcchristian@sbcsd.org</u>) or me if we can be of any assistance on this matter.

The Sheriff joins the California State Sheriff's Association (CSSA) in their opposition to Senate Bill 918 (Portantino) and has made his stance clear to members of the California State Assembly. Today, the Sheriff addressed his concerns about this bill and its suggestion that CCW permit holders are responsible for gun violence in this country. We are sharing the letter sent to Senator Portantino and wish to convey to the residents of San Bernardino County that the Sheriff supports those that believe the ability to possess a firearm is a fundamental right to protection and he will continue to defend that right.






How blessed & lucky have we been. -Alex M.

<u>Pistol Caliber Carbines (PCCs) are now allowed on</u> <u>Pistol Ranges - P1 through P3 ONLY</u>

ONLY calibers listed below:

- .380 ACP
- 9x19mm (Luger/Parabellum)
- .38 SPL
- .40 S&W
- .45 ACP


NO carbines chambered in Magnum or Rifle cartridges are allowed.

Additional Rules Apply:

- ONLY 1 shooter forward of the bench at a time.
- Unarmed Range Officer may accompany the shooter.
- PCCs not in use must have the bolt locked open and empty magazine well.
- Chamber flags recommended, but not required.
- PCCs should be on a rack, in a match wagon or laid on the bench, muzzle downrange.
- PCC to Pistol transitions and vice versa are to be done via the use of "Dump" boxes or barrels.
- NO slung carbines
- Pistols should be holstered in a rigid plastic/kydex holster with trigger covered.

Target Rules:

- All targets must be addressed in the "down range" direction.
- All targets should be within 45 degrees of center.



- All steel targets must be at least 50 ft from shooter's position.
- Please follow all standard safety regulations and protocols for all AVGC ranges.
- P4 NO PCCs OR METALLIC TARGETS



AG Bonta: "Good Cause" Requirement Is Unconstitutional

In the wake of the <u>NYSRPA v Bruen</u> decision, California Attorney General Rob Bonta issued a Legal Alert to all law enforcement officials across the state declaring the "good cause" requirement for a CCW permit unconstitutional. Bonta goes on to specifically direct permitting agencies that they "may no longer require a demonstration of 'good cause' in order to obtain a concealed carry permit".

UPDATE on AB 2571*

The twisty path of AB 2571 took a pretty wild turn a couple weeks back when the court granted the Legislature another "bite at the apple" in an attempt to get the new law to pass legal muster. Lawmakers dutifully sharpened their pencils and went back to work, trying to make the unconstitutional somehow constitutional.

With the adoption of new amendments in the beginning of September, people were naturally curious as to their impact. In short, the changes made the law even more confusing and vague, but there is a LOT to it. So, the team at the CRPA has assembled a document that addresses all the facets of how this law could be applied.
