We are once again providing CCW qualification courses for the sheriff's department – a considerable income for the club and a considerable benefit to county residents looking to get their CCW permit. Our NRA classes are running strong with good attendance and some great new instructors joining the club's training team. The building known as the Rifle Shack by some members and the Cook Shack by those who have been around longer, has been remodeled into three much needed storage rooms and a clean, organized snack room for the rifle range. As I write this, we just received a new, wireless speaker system for our trap ranges. If you haven't tried trap, you should, it's great fun and we have great instructors to get you started. Look for open trap on the calendar.

We just installed a large new TV screen in the trap classroom. The secretary's office also received some much-needed fresh paint and decoration. We have a new, fast, large printer to save us printing costs on club documents and newsletters. The archery range has been slowly replacing all the old straw bales with new. 3D archery has been gaining participants and hopefully we will soon replace the deteriorating 3D targets. We've had two successful "Meet and Greet" for all club members to get to know the "leaders" of the club (Board members, Range Chairmen, and Match Directors). The crumbling Adobe chimney has been repaired and the leaky roof has been replaced, removing lots of old vents and other covered openings no longer needed. There are many more small improvements that won't even be noticed by most of our members. Just know that your board

and other directors and chairman are constantly working to make needed improvements and spend club dollars practically and responsibly.

Currently I am spear-heading the movement to allow members to choose between joining NRA or CRPA with their annual renewal. Please read your ballots and vote for your choice. Last, I want to thank everyone for all their support this year. I've really enjoyed the last two years serving the club as VP and then President. FROM THE VICE PRESIDENT

Wow! Blink twice and the year is almost over! This year has been one of continued growth for the Club, both in new members and in improvements to our facilities. We finally got a muchneeded roof replacement for the Adobe that should last another 25 years. We're in the final stages of the installation of a range-wide emergency shut-down system, and we've completed several upgrades in our training equipment, both in the classrooms and on the ranges.

With a core group of about 20 amazing volunteers, the Sheriff's CCW re-qualifications were going great until the passage of Senate Bill 2, which closed our CCW training for half of the year. On the positive side, with several newly minted DOJ Firearms Instructors, the Club is now an authorized vendor with the Sheriff's Dept to provide both the 8-hour renewal and the 16-hour training classes. Anyone who has renewed their CCW recently or completed their initial certification can attest that our process is quick, easy and most of all, safe.

The Match Guys have come up with several new matches over the year, including a Tactical Shotgun Match, a Precision Rifle Match and a Precision .22 Rifle Match. Great skill-builders!

While the Club is a great place to come to shoot, either alone or with friends, it's our volunteers who are the lifeblood of the Club. Without those who continually dedicate their time, energy and expertise to bring our visions to fruition, it would still be the pile of rocks with a few targets that it was when I first came to the range back in 1982. If you're not one of those outstanding volunteers, I ask that in the coming year you look around the range and find places where your skills can be used to make it better for all.

Thank you all for your support, and I look forward to seeing you somewhere around our Club.



- Proof of current NRA membership (lifetime members do not need to resubmit)


CCW Initial and Requalifcations Returns to AVGC!
